- Grilled ham and cheese \$4.00
- Chocolate shake \$2.00
- Hot Chocolate \$1.00
- Coffee \$1.00
- Orange juice \$1.00
- Milk \$1.00

Please plan your coupons using this price list. This year we will also be offering the following discounts:

- If you purchase \$500-\$999 worth of coupons, you will receive 5% off your total bill.
- If you purchase \$1,000-\$1,999 worth of coupons, you will receive 8% off your total bill.
- If you purchase \$2,000+ you will receive 12% off your total bill.

Your company will only be charged for the amount of coupons reimbursed during the week of Expo, not the amount you originally printed. After Expo, you will receive a bill for the amount of coupons reimbursed.
